

Privacy policy

Below we describe the modalities of management of the site fantaurovision.com with reference to the treatment of the personal data of the users that use it.

The Data Controller and Data Protection Officer

The Data Controller is Mk2 srls (hereinafter also the Data Controller or fantaurovision.com), via Bruno Buozi, 46, Civitanova Marche (MC) and can be contacted by email at info@quellidifantasanremo.com. The Data Controller has appointed its own Personal Data Protection Officer who can be contacted at privacy@wslegal.it.

Place of personal data processing

The processing operations connected to the web services of this site take place at the premises of Mk2 srls, which makes use of external providers for the web site hosting service and are carried out by technical staff authorized to process the data and, occasionally, by external and internal staff for maintenance operations. Personal data will be stored on servers of the Data Controller, or its suppliers located within the territory of the European Union. Except as further indicated, the data will not be transferred outside the European Union.

Types of data processed

1. Data deliberately supplied by the user

The voluntary and explicit sending of e-mail messages to the addresses indicated in the various access channels of the site and the filling in of the forms specifically provided (e.g. contact form) entails the acquisition of the sender's e-mail address and data, which are necessary to respond to the requests made. Sending this data is done on an optional, explicit and voluntary basis, and involves the subsequent acquisition of the data transmitted: we will process this data assuming that it refers to the sender. Please do not send any personal data unless strictly necessary: certain categories of personal data can only be processed with the explicit consent of the user and in accordance with current legislation. Specific summary information will be reported or displayed on the pages of the site set up for particular services on request.

2. Navigation Data

The computer systems and software procedures used to operate the website fantaurovision.com acquire, during their normal operation, some personal data whose transmission is implicit in the use of Internet communication protocols. This information is not collected to be associated with identified interested users, but by their very nature could, through processing and association with data held by third parties, allow users to be identified. These data are used for the sole purpose of obtaining statistical information not associated with any user identification data on the use of the site and to check its correct operation and are deleted immediately after processing or within a few days at most. The data could be used to ascertain responsibility in the event of hypothetical computer crimes to the detriment of the Site. This data is stored in our systems or in those of service providers, who act as data processors for the management of the website. The site is hosted on servers located in Europe.

3. System Log

The Access to the site, consultation of its contents and use of its services enables the web server to automatically record so-called 'system LOGs', i.e. information that the user's browser sends while browsing the site. This information consists of the web pages requested by the user, the

documents consulted, modified or created, the IP address, browser type, browser language, date and time of the request.

4. Statistical Data

Statistical analysis services allow us to monitor and analyze traffic data in order to measure the performance of the site for research purposes, usability evaluations and interest. This site uses Plausible Analytics (<https://plausible.io/>), a service for the statistical analysis of browsing activities. Plausible Analytics uses the user's personal data for the purpose of examining the use of this site and compiling statistical reports. Data processing takes place in Europe. 5. Cookies

This section of the sites sends visitors some files commonly known as cookies. Cookies will be used by your computer's browser, solely to store the website user's session information. If you prefer not to receive cookies or wish to be informed about them in advance, you can set your web browser accordingly. However, we would like to inform you that without this active feature, you cannot access the forum section on the Company's websites correctly. 6. Registration data and social login

When registering for the fantaeurovision game and creating an account, you will be asked to provide certain personal data, such as your nickname and e-mail address.

You may also be allowed to register and authenticate to the web app using social service accounts or other digital services you already use, without having to provide any additional passwords. The interactions and information acquired and transmitted by this web app are limited to name/nickname and do not concern authentication credentials or other data. The information transmitted is in any case subject to the user's privacy settings related to the service used.

The information requested during registration will be used to allow access to online services and to ensure the proper performance of all activities connected with or instrumental to the provision of such services.

By accessing through Social Log In app.fantaeurovision.com will receive your data from the social networks, but it will process them exclusively to allow you to use the services of the web app.fantaeurovision.com will not receive from the social networks any data different from the above mentioned ones, even in case you have expressly given these social networks additional data, which may be processed by the social network on the basis of the authorizations and consents given by you to the latter, as autonomous data controllers.

Profiling by automated processing of personal data

Automated user profiling systems are not active for advertising purposes, aimed at analysing or predicting aspects of the user's browsing habits on the basis of the user's browsing activities.

Purpose and legal basis of data processing

We process personal data for different purposes, which we specify below:

1. Request management and service delivery

2. Managing registration and game participation

thus enable us to protect ourselves in court if necessary.

3. Marketing and sales promotion activities

Purpose of processing

Soft spam communications may be sent to users concerning promotional content of services similar to those already offered.

Legal basis and the need to provide data

The processing is carried out in the pursuit of the legitimate interest of the data controller, (Art. 6(1)(f)), unless expressly refused or subsequently revoked by the user. Consent is not necessary. The user, on the occasion of the sending of each communication, shall have the right to express his/her will to stop receiving the communication by means of the unsubscribe procedure.

2. Purpose of processing navigation data and system logs

Personal data whose transmission is implicit in the use of Internet communication protocols and system LOGs are processed solely for the purpose of obtaining anonymous statistical information on the use of the site, to check its correct operation and to protect the computer systems that enable it to function. The data do not permit the identification of the persons concerned and are not associated with other sources of data that could permit assimilation such as to identify users.

Obligation to provide personal data

Apart from the above-mentioned navigation data, the user is free to provide his or her own data. Failure to provide personal data, however, may make it impossible to take part in the game or to laugh at support.

As regards the receipt of soft spam, this can always be blocked by the user by revoking consent.

Methods of processing

We process personal data by both automated and pseudo-automated means and for the time strictly necessary to achieve the purposes for which they have been collected and for the pursuit of the purposes set out in this policy. Processing is carried out by specially appointed personnel, mainly with the aid of electronic, computerized, or otherwise automated means, through the use of electronic mail or other remote communication techniques.

Data retention period

The personal data collected by the web app are kept for the period of time necessary to achieve the purposes of the processing, i.e. for the duration of the fantaeurovision game and also thereafter, for as long as you are active and for the duration for marketing and sales promotion purposes, in relation to the purposes and legal bases specified above. Should you decide to delete your account, your data will be deleted from our systems, or made anonymous for statistical purposes, with the exception of LOG data and data necessary to guarantee the security of the system and the storage obligations prescribed by law or the data subject's indication to the contrary. In any case, we may process personal data for as long as permitted by law, in particular as may be necessary to protect our interests from possible claims or in the event of litigation.

Data security

We adopt specific security measures, appropriate and preventive, in order to safeguard the confidentiality, integrity, completeness and availability of personal data, as well as to prevent the loss of data, illicit or incorrect use and unauthorized access. In particular, the site uses an encryption system with SSL (Secure Sockets Layer) technology, which guarantees protection by encrypting information both on the login page and in the other sections where you can release, view or modify your personal data. In any case, we are not responsible for untruthful or incomplete information sent directly by the user (e.g. correctness of e-mail address), as well as information concerning the user that has been provided by a third party, even fraudulently.

Personal data recipients

For the provision and management of services, personal data may be communicated to other subjects, in their capacity as autonomous Data Processors and/or Data Controllers (such as, for example, web service providers, e-mail or technical services that provide services instrumental to the provision of site services, subjects that provide technical, administrative, legal, etc. assistance and consultancy in relation to the provision of services, internal staff authorized to process data and bound by confidentiality obligations) to the extent necessary to carry out their duties for us, and have committed themselves to confidentiality, including with appropriate legal obligations. The data may also be disclosed to persons, entities or authorities for legal obligations, protection against abuse or fraud, or by order of the authorities. The full list of the subjects is available upon request.

Exercise of rights by users

The subjects to whom the personal data refer have the right at any time to obtain confirmation of the existence or not of the same from the Data Controller, to know the content and origin, to verify their accuracy or ask for their integration, the cancellation, updating, rectification, transformation into anonymous form or blocking of personal data processed in violation of the law, as well as opposing in any case, for legitimate reasons, their processing. Terms of Use

Fantaeurovision cannot be used to commit or facilitate illicit or deceptive acts, or acts prejudicial to the rights of third parties, nor for the promotion of products or services, without the prior written authorisation of Mk2 S.r.l.s. The webapp does not assume any responsibility for the submission of personal data of third parties and therefore on a possible illicit treatment by the users themselves. Only persons who have reached the age of 14 may register for the game, and the data controller may suspend profiles if it detects irregularities.

We reserve the right to change or update the content of this privacy policy in connection with changes in applicable law. All changes and updates will be binding as soon as they are published on the site.
